Please note that for the purpose of full membership of ICTPI on has to complete the the specified professional orientation course of ICTPI. It is also worth noting here that exit route after first four exam is optional, one can continue to complete rest of the four exams to become CPA & obtain ICPA membership directly, then after also can get ICTPI membership additionally to get dual recognition or awards.
